DEADLINE FOR ABSTRACT SUBMISSION: **1 OCTOBER 2016**

The European Conference on Argumentation (ECA) is a pan-European biennial initiative aiming to consolidate and advance various strands of research on argumentation and reasoning by gathering scholars from a range of disciplines. After a successful 1st edition held in Lisbon in 2015, ECA will be hosted in 2017 by the Department of English at the University of Fribourg, Switzerland. While based in Europe, ECA involves and encourages participation from argumentation scholars all over the world.

Special Theme: *Argumentation and inference*

In addition to welcoming submissions linked to argumentation studies in general, each ECA edition has a special theme. While the 1st edition of ECA was devoted to exploring the relationship between argumentation and the decisions that follow from it, the 2017 Fribourg edition will focus on the cognitive processes involved in argumentation, with a clear focus on **inference** as one of the key features of the argumentative process. Argumentation studies have increasingly expanded over the last decades with a clear opening towards cognitive science, and we accordingly believe that the time is ripe to ground a discussion in the community around the notion of inference, along its formal, social and cognitive dimensions. The overarching questions the conference theme will be concerned with are therefore the following: How does the study of argumentation connect with the notion of inference and how, as a discipline, does it connect with the disciplines involved in the study of the cognitive features of inference? Granting, of course, that we take argumentation to be the verbal and social manifestation of inferential processes, we are particularly seeking contributions focusing on the ins and outs of (i) how reasoning, but more generally inference, influences and constrains argument production and (ii) which (and how) inferential processes are involved in argument reception, thus covering cognitive tasks such as understanding and accepting.

To foster this discussion, the conference seeks to attract scholars in argumentation coming from a range of different traditions, including (but not limited to) philosophy, psychology, linguistics, informal logic, speech communication, pragma-dialectics, epistemic approaches, rhetoric, dialectics, logic, and computational approaches. The lines of inquiry promoted for ECA 2017 in Fribourg are the following, but this indicative list is neither exhaustive nor limitative:

Submissions from students and young scholars are encouraged. To this end, ECA has established the [Frans van Eemeren Prize](#) for Outstanding Student Paper sponsored by Springer. The winning paper will be awarded a 500 € (around 575 US\$) cash prize and additional 300 € (around 345 US\$) in books from Springer's catalogue.

Location

Fribourg is a charming medieval university town in central Switzerland, ideally situated half-way between Geneva and Zürich – train connections from both airports are therefore easy, frequent and efficient. The city is officially fully bilingual (French, German) and is considered as the crossroads between French and German Switzerland. The region is, expectedly, well-known for its cheese (Gruyère cheese actually comes from the region of Gruyères, a half-hour drive from Fribourg) and its chocolate. Abstract submission

The Programme Committee and Organising Committee invite 4 types of original submissions, defined as follows:

- 1) Long paper (with commentator)
Submit an **extended abstract** (min. 1'000, max. 1'500 words), ready for double-blind reviewing. Each accepted paper will then have to be submitted prior to the conference (see important dates below) and will have a commentator assigned. Authors will be allocated longer slots (\pm 45 min.). Published long papers will be within the 5'000-7'000 word range (incl. references and footnotes).
- 2) Regular paper (without commentator)
Submit a **regular abstract** (min. 300, max. 500 words) ready for double-blind reviewing. For authors of accepted regular papers there is no need to submit them in advance, and there will be no commentator. Authors will be allocated shorter slots (\pm 25 min.). Published regular papers will be within the 3'500-5'000 word range (incl. references and footnotes).
- 3) Thematic panel/symposium
A **thematic panel/symposium** is expected to be directly related to the main theme of the conference. Panels should allow 3 to 5 speakers to present and will last between 90 and 150 min. They may include a panel respondent (panel organiser(s) or someone invited by the panel organiser(s)). Panel proposals are submitted by the panel organiser. They should be prepared for double-blind reviewing and include a title, a description of the panel, including its connection to the conference theme (300-500 words), the titles and abstracts of all contributions to the panel (300-500 words each) and the name of the respondent if applicable. Published panel/symposium papers will be within the 3'500-5'000 word range (incl. references and footnotes). Please note that all abstracts in the panel/symposium should also be individually submitted by their authors as 'Regular papers'; this must be done by ticking the option "My paper is part of a thematic panel/symposium" which will be available in the submission system under the abstract box.
UPDATE: Please note that **book panels** should be submitted under this category.
- 4) Poster
Submit a **regular abstract** (min. 300, max. 500 words) ready for double-blind reviewing. For authors of accepted posters there is no need to submit them in advance. Posters will neither be assigned a commentator nor published. A poster session will be organised in a dedicated time slot during the conference. Please prepare a printed A1 poster and not a hand-written one.

Submission policies

Please bear in mind the following policies as you submit your abstract:

- Submissions may be singly or jointly authored.
- Authors may submit more than one abstract, but this is discouraged and will be taken into account when accepting papers.
- Authors can only appear as main author once, as the conference policy is 'one abstract-one registration'. The only exception to this is when an author presents a panel contribution and an individual paper (long, regular or poster).
- Submissions must be anonymous. That is, the abstract cannot contain any information by which the author(s) can be identified, e.g., no author names.
- All abstracts will be double-blind peer reviewed for their overall quality and relevance to the conference by the members of the Scientific Committee (see below).
- All abstracts must be submitted on EasyChair by **1 October 2016**, 23:59 (UTC + 01:00) on the following link (available as of 8 July 2016): <https://easychair.org/conferences/?conf=eca2017>
- Notification of acceptance/rejection will be sent by **early December 2016**

The fees include all conference material, lunches, coffee breaks and welcoming reception on the first evening of the conference and administrative costs. A conference dinner is planned at an extra fee of 50.- CHF. Registration (including fee payment) will be open to accepted participants in early 2017.

The ECA organising committee has factored in as much as possible the costs involved in traveling to/in Switzerland in its planning of the conference. To make this more manageable, 3 measures have been taken:

1. Registration fees are commensurate with those of the first edition of the conference, ECA2015 in Lisbon.
2. Applications for special funds have been submitted in the hope of being able to offer fee discounts for PhD students. More information will be available on our website once we get word from our funding bodies.
3. Accommodation options, which will be available through our partner ARTEFACT-SA by the time registration opens, will include a range of offers among the cheapest deals in Fribourg during the period of the conference.

ECA summer school

The 1st ECA summer school will take place at the [Università della Svizzera Italiana](#) in **Lugano** prior to the ECA conference, from 16 to 19 June right before ECA2017 in Fribourg. The summer school will introduce PhD students to cutting-edge research in argumentation theory from different theoretical angles. A specific sub-topic will cover different interpretations of the notion of 'inference' within argumentative discourse and argumentative reasoning. Participants will be invited to reflect on and discuss different approaches to argumentation. The analysis and evaluation of inference, in a logical, pragmatic, and cognitive sense will be also tackled including, but not limited to, insights into the study of argument schemes and fallacies.

Guests will get the opportunity to participate in the summer school and afterwards (20 June) will be able to easily travel to Fribourg by train to attend the second edition of the ECA conference.

The summer school is divided into 2 main classes (8 hours each) and 2 seminars (4 hours each). Each class is divided into 2 working days, and will be taught by Prof. Frans VAN EEMEREN (UvA and ILIAS, Amsterdam) and Prof. Jean GOODWIN (North Carolina State University, USA). The seminars will be chaired by Fabio PAGLIERI (ISTC

Rome, Italy) and Sara GRECO, Anne-Nelly PERRET-CLERMONT and the team of the project “Analysing children’s implicit argumentation”.

Fees:

- CHF 175 for PhD students who take part in the ECA conference.
- CHF 250 for PhD students who do not take part in the ECA conference.
- CHF 100: partial attendance (1 main class + 1 seminar)

Fees include participation in the summer school, a welcome reception, and all materials. Accommodation is not included, however, please note that convenient and affordable hotel suggestions will be published on this webpage in due time.
